

High Court to Rule on Stolen Valor Act October 17, 2011 Associated Press/by Mark Sherman

WASHINGTON - The Supreme Court will decide whether a law making it a crime to lie about having received military medals is constitutional.

The justices said Monday they will consider the validity of the Stolen Valor Act, which passed Congress with overwhelming support in 2006. The federal appeals court in California struck down the law on free speech grounds and appeals courts in Colorado, Georgia and Missouri are considering similar cases. The Obama administration is arguing that the law is reasonable because it only applies to instances in which the speaker intends to portray himself as a medal recipient. Previous high court rulings also have limited First Amendment protection for false statements.

The court almost always reviews lower court rulings that hold federal laws unconstitutional.

The case concerns the government's prosecution of Xavier Alvarez of Pomona, Calif. A member of the local water district board, Alvarez said at a public meeting in 2007 that he was a retired Marine who received the Medal of Honor, the nation's highest

military decoration. In fact, he had never served in the military.

He was indicted and pleaded guilty with the understanding that he would challenge the law's constitutionality in his appeal. He was sentenced under the Stolen Valor Act to more than 400 hours of community service at a veteran's hospital and fined \$5,000.

A panel of the San Francisco-based 9th U.S. Circuit Court of Appeals voted 2-1 to strike down the law. The majority said there is no evidence that lies such as the one told by Alvarez harm anybody and no compelling reason to make a crime out of them. In a dissent, Judge Jay Bybee said his colleagues should have followed previous Supreme Court rulings holding that false statements are not entitled to First Amendment protection.

The appeals court refused the government's request to have the case heard again by a larger group of judges. Chief Judge Alex Kozinski, agreeing with the majority, said people often tell lies about themselves in day-to-day social interactions. He said it would be "terrifying" if people could be prosecuted for merely telling lies.

But seven appellate judges said they would have heard the case, suggesting that Alvarez's conviction should have been upheld.

The law had been the latest congressional effort to try to keep people from wearing medals they did not earn. But it was the first time that lawmakers made it a crime for someone to claim falsely that he had been awarded a medal.

The law has led to dozens of arrests at a time when veterans coming home from wars in Afghanistan and Iraq are being embraced as heroes. Many of the cases involve men who were not accused of trying to profit from their claims. Almost everyone convicted under the law has been ordered to perform community service.

Arguments will take place early next year. The case is U.S. v. Alvarez, 11-210

Suit alleges banks and mortgage companies cheated
veterans and U.S. taxpayers

Some of the nation's biggest banks and mortgage companies have defrauded veterans and taxpayers out of hundreds of millions of dollars by disguising illegal fees in veterans' home refinancing loans, according to a whistleblower suit unsealed in federal court in Atlanta.

The suit accuses the companies, including Wells Fargo, Bank of America, J.P. Morgan Chase and GMAC Mortgage, of engaging in "a brazen scheme to defraud both our nation's veterans and the United States treasury" of millions of dollars in connection with home loans guaranteed by the Department of Veterans Affairs.

"This is a massive fraud on the American taxpayers and American veterans," James E. Butler Jr., one of the lawyers bringing the suit, said Tuesday. Tens of thousands of the VA loans have gone into default or resulted in foreclosures, resulting in "massive damages" to the U.S. government, the suit alleges. The faulty loans will cost taxpayers hundreds of millions of dollars, with the costs rising as more VA loans go into default, according to the suit. The two mortgage brokers who brought the suit said in an interview that they were instructed by the lenders not to show attorney's fees on their estimates, but to add them to the title examination fee. Under VA rules, lenders can charge veterans for recording fees and taxes, credit reports and other customary fees, but they are not allowed to charge attorney's fees or settlement closing fees. "It was gutwrenching to us, seeing the brazenness" of the lenders, broker Victor E. Bibby said.

The case involves refinanced loans that are available to retired or active-duty veterans on homes they already own. The program is aimed at giving veterans the opportunity to lower their interest rates or shorten the terms of existing home mortgages.

The whistleblower suit, which was unsealed Monday, seeks to recover damages and civil penalties on behalf

of the U.S. government. The Justice Department has notified the U.S. District Court that it is not taking over the case but is reserving the right to intervene at a later date, according to court papers.

"The government has not yet made a decision about whether to intervene in this case," Sally Quillian Yates, United States attorney for the Northern District of Georgia, said Tuesday. "As the case develops, we will continue to evaluate the merits of the case, and we will consider intervening . . . if it becomes appropriate to do so."

"This is a very significant case," Patrick Burns, spokesman for the nonprofit Taxpayers Against Fraud, said Tuesday. "It deals with widespread fraud from veterans who were personally pickpocketed for hundreds if not thousands of dollars, and the liability has been shoved on the federal government." During the past decade, more than 1.2 million of the refinanced loans have been made to veterans and their families, and up to 90 percent may have been affected by the alleged fraud, according to attorneys for the plaintiffs.

"The banks collected hundreds of millions of dollars in hidden fees from veterans, and they obtained hundreds of millions of dollars in loan guarantees they otherwise wouldn't have received," said Mary Louise Cohen, a Washington attorney who is also representing the whistleblowers.

The case has been brought under the False Claims Act by two mortgage brokers in Georgia, and has been under federal seal since it was filed in 2006 in U.S. District Court for the Northern District of Georgia. Cases brought under the act often remain under seal for years while they are investigated.

Three of the companies named in the suit — Wells Fargo, Bank of America and SunTrust Mortgage — declined to comment.

Speaking on background, representatives of two banks said the government's decision to not intervene yet means the Justice Department does not think it's a strong case. But Burns, whose organization monitors whistleblower cases, said the government's decision to allow private law firms to take the lead was not unusual given limited resources for investigating alleged fraud.

"God help any bank that takes this case to trial," Burns said. "A jury's only question is going to be 'How much do they have?'"

The suit includes as an exhibit a loan document in which Wells Fargo reported a \$950 title examination rather than "a reasonable and customary fee" of between \$125 and \$200. Banks collected anywhere from \$300 to \$1,000 per loan in hidden fees by adding the prohibited charges to the allowable fees, according to the suit.

Bibby, one of the plaintiffs, is president and chief executive of U.S. Financial Services, a Georgia-based corporation that provides mortgage services in seven states. As brokers, Bibby and the company's vice president of operations, Brian J. Donnelly, helped veterans choose lenders and complete the application forms. Since 2001, their company has helped set up thousands of the veterans' refinancing loans, according to the suit.

In 2005, Donnelly said he read the rules in a VA handbook governing the fees that could be charged for the transactions, which are known as Interest Rate Reduction Refinancing Loans, or IRRRL loans. Donnelly, who served three years in the Army, did further research and said, became convinced that the charges were fraudulent. "We knew it was wrong," he said.

"We started putting two and two together," Bibby said. "It was kind of like a coconut hitting us on the head. They're hiding it intentionally." Bibby and Donnelly said they approached the lenders, who insisted they were doing nothing wrong. The brokers reported their allegations to the U.S. government, providing copies of hundreds of "fraudulent transactions." Upon filing the whistleblower lawsuit, the court ordered the case sealed.

Earlier this year, Wells Fargo agreed to a \$10 million settlement in a separate class-action lawsuit that alleged it improperly added attorney's fees to about 60,000 refinancing loans for veterans.

Other companies named as defendants include CitiMortgage, Washington Mutual Bank, PNC Bank (which acquired National City Mortgage), Countrywide Home Loans, Mortgage Investors, First Tennessee Bank (which acquired First Horizon Home Loan), Irwin Mortgage and New Freedom Mortgage. VA Support Program Expanding to More Veterans, Spouses/ Spouse Telephone Support Program Demonstrates Improved Quality of Life WASHINGTON (Nov. 18, 2011) –

The Department of Veterans Affairs is implementing a telephone support program to help the spouses of returning Iraq and Afghanistan Veterans, after a pilot telephone support program showed significant reduction in stress for spouses.

"Returning to civilian life after living in constant combat readiness can be a shocking transition, and it is the immediate family, the spouses and children, who bear that brunt of that transition with those who served," said Secretary of Veterans Affairs Eric K. Shinseki. "The more support we can provide to the family, the better the outcome will be for our Veterans."

The spouse telephone support program, which is part of VA's Caregiver Support Program, builds spouses' ability to cope with the challenges that reintegration to civilian society can bring, helps them serve as a pillar of support for returning Veterans, and eases the transition for families after deployments. Spouses in the pilot program reported decreased symptoms of depression and anxiety, with an increase in social support.

Spouses participate in 12 telephone support groups over six months. The focus is on problem-solving and

communication, relationships, mental health and resilience. A trained, nationwide team of VA medical center staff members, including many caregiver support coordinators, will lead the support groups. Typical issues spouses and Veterans face after deployment include communication difficulties, the need to renegotiate family roles and responsibilities and the added stress of combat related injury. Spouses of Veterans returning from Iraq and Afghanistan have reported feeling overwhelmed, depressed, anxious and frustrated.

"Providing support to family caregivers is the right thing for VA to do," said Dr. Robert Petzel, VA's under secretary for health. "A simple series of phone calls can do so much good. Certainly, those who fought for our nation and the spouses who allowed them to make that sacrifice deserve this support." The program is based on research by VA researchers Dr. Linda Nichols and Dr. Jennifer Martindale-Adams, of the Memphis VA Medical Center and the University of Tennessee Health Science Center. Both researchers developed and studied interventions for family members of Veterans and military personnel. Their work with spouses of post-deployed and deployed military personnel is funded through the Defense Health Program, managed by the U.S. Army Medical Research and Materiel Command. Local caregiver support coordinators are available to assist Veterans and their caregivers in understanding and applying for VA's many caregiver benefits. VA also has a Web page, www.caregiver.va.gov, with general information on spouse telephone support and other caregiver support programs available through VA and the community.

Current Information Regarding DD-214's Please pass on to other vets. It's official: DD-214 discharge papers are NOW ONLINE.

The National Personnel Records Center (NPRC) has Provided the following website for veterans to gain access to their DD-214s online:

This may be particularly helpful when a veteran needs a copy of his/her DD-214 for employment purposes. NPRC is working to make it easier for veterans with computers and Internet access to obtain copies of documents from their military files.

Military veterans and the next of kin of deceased former military members may now use a new online military personnel records system to request documents.

Other individuals with a need for documents must still complete the Standard Form 180, which can be downloaded from the online web site. Because the requester will be asked to supply all information essential for NPRC to process the request, delays that normally occur when NPRC has to ask veterans for additional information will be minimized. The new web-based application was designed to provide better service on these requests by eliminating the records centers mailroom and processing time.

MARINE TIDBITS:

1 November 1983: 300 Marines of the 22d Marine Amphibious Unit staged an amphibious and helicopter landing on the island of Carriacou, 15 miles northeast of Grenada, in a search for Cuban military installations or personnel. 17 Grenadian soldiers were captured, and arms, ammunition, and training sites were found. The next day the 22d MAU left the Caribbean area and proceeded to Beirut, Lebanon to replace the 24th MAU.

8 November 1990: President Bush announced that he planned to add more than 200,000 U.S. troops to those already deployed in Operation Desert Shield in the Persian Gulf area. The number of Marines in the area would be doubled by the addition of II MEF units from the Corps' east coast bases, and the 5th MEB from California. Within the next two months, Marine strength in the objective area would increase to nearly 90,000 Marines.

10 November 1921: This date marked the first formal commemoration of the birthday of the Marine Corps as 10 November. On 21 October 1921, Maj Edwin McClellan, OIC of the Historical Section, HQMC, sent a memo to MajGen Commandant John A. Lejeune, suggesting that the original birthday of 10 November 1775 be declared a Marine Corps holiday to be celebrated throughout the Corps. Accordingly, on 1 Nov 1921, Gen Lejeune issued Marine Corps Order No. 47 summarizing the history, mission, and tradition of the Corps, and directed that it be read to every command each 10 November.

13 November 1982: The Vietnam Veterans Memorial, containing the names of more than 13,000 Marines who lost their lives in Vietnam, was dedicated this date at the Memorial site in Washington, D.C. The dedication and parade that preceded it were part of a week-long National Salute to Vietnam Veterans

17 November 1918: The 4th Marine Brigade, as part of the 2d Division, American Expeditionary Force, began its march to the Rhine River, passing through Belgium and Luxembourg, as part of the American forces occupying a defeated Germany.

20 November 1943: The 2d Marine Division, commanded by Major General Julian C. Smith, landed on Betio Island, Tarawa Atoll, Gilbert Islands. After seventy-six hours of bitter fighting during which almost 1,000 Marines died, and more than 2,000 were wounded, MajGen Smith declared the island secure.

24 November 1992: Marines lowered the flag at Subic Bay, U.S. Naval Facility, Republic of the

Philippines, for the last time during ceremonies to turn over the facility to the government of the Philippines. The withdrawal ended almost a century of U.S. presence in that nation.

25 November 1968: The conclusion of Operation Lancaster II ended 10 months of action against the Viet Cong and North Vietnamese Army troops in the west-central sector of the demilitarized zone region. Over 1,800 enemy were killed, 42 captured, and 913 weapons seized during the operation.

27 November 1950: In a carefully planned assault, eight Chinese Communist divisions in Korea launched a massive attack which had as its expressed purpose, the destruction of the 1st Marine Division. This action led to the successful southward Marine Corps attack out of the Changjin (Chosin) Reservoir to the coastal port of Hungnam

Peter White

In 1952 my friend Nick Castronuovo and I were dying to go into the Marine Corps but his parents would not sign for him so we had to wait until he turned 17.

To help kill time, I decided to hitchhike to California to see my sister who had moved there after her marriage to a Sailor. What an adventure! I think God had me take this trip to help prepare me for the Marines.

After my return home and Nick's birthday we enlisted and on May 26, 1953 I became Private Peter James White, 1366777, a U.S. Marine recruit.

Halfway through Boot Camp the truce was signed and so we were not sent to Korea to battle as so many others were. Instead, the training schools were opened and activated. Upon graduation in the First Battalion, Platoon 175 at Parris Island, I was selected to go to Camp Lejeune and report to Headquarters Co, 2nd Battalion Engineers where I was given my MDS#1364 Road Grader. I thought "what is a road grader?" but didn't get much more explanation. As we were assembled in formation a Sgt. With a loud voice asked if there was anyone who did not know how to drive...he repeated it in an even louder voice. I slowly raised my hand (I remember thinking I've never heard an accent like that-it was Southern) and the Sarge called me forward. As I stood there he told

the rest of the group that he was personally going to teach Private White how to drive because he doesn't have any bad driving habits.(see picture)

After graduation and three weeks leave I reported to Camp Pendleton CA for reassignment. I received orders to report to Camp Okubo, Japan with Headquarters Company 3rd Engineer Battalion. I was put in charge of my Road Grader and had to maintain her and all the moving parts and be at the ready at all times.

One TDY job we were asked to do was at a local Convent. They wanted us to grade a school recreation field for soccer. We were told to report any live Ammo if we saw it.

That winter we were put on alert to be ready to move the base, lock, stock and barrel, to the Port of Yokohama for deployment to the China Sea. (Scuttlebutt had it we were off to help the French at Dien Bien Phu.) After three months the orders were to stand down, as the French had surrendered. Later we were told to pack up to move to Okinawa. Our mission was to build enough bases so the Marines in Japan could withdraw (allegedly as agreed on at the end of the war). The Engineers worked day and night to reach our goal. In 3 months time we built 3 ½ bases. Feeling good about our accomplishments we were in the beer hall and a Marine in another group yelled,"Hey White, You are supposed to pullout with the next group but I think I'm going to lose your orders". After I set him straight I discovered I had a broken wrist and in fact shipped out a month after my company.

As our Strato-cruiser was landing in California we received a 30 day leave and assignment to Camp Lejeune, N.C., 1st Marine Division, Headquarters Company, 1st Engineer Battalion.

I was discharged on May 25, 1956.

I used the GI Bill to attend SRT School of Radio and Television in New York. Upon graduation I headed south looking for a position is a broadcast station. I landed in Tampa and stopped at WFLA-TV to talk to the station manager. He gave me the job on the spot,

February 25, 1958. I retired in 1983 as a Producer-Director.

Since then I have worked in various other communication settings and finally retired in 1990. My family and I have lived in Riverview since 1967 and we have watched it grow from a quiet rural setting to the bustling area it is today.

HERO OF THE MONTH



The Marine Corps helped shape the life of Daniel M. Angus and turned him into a man. He survived two tours of duty in Iraq, but now his family is planning his funeral after he was killed in an explosion in wartorn Afghanistan.

Angus, 28, of Thonotosassa, died Sunday while on foot patrol in the Helmand province when an improvised explosive device detonated, said his mother, Kathy Angus. Two other Marines also were killed.

"He died doing what he loved," his mother said of the 2000 Armwood High School graduate. "He loved the Marine Corps and he gave his life for it."

Angus was working construction and living in Thonotosassa with little direction a few years back. He joined the U.S. Marine Corps in 2003, hoping "to accomplish something in his life," Kathy Angus said. He succeeded and rose to the rank of sergeant. He knew he had found his calling and was planning to make the Marine Corps a career.

"He found himself," Kathy Angus said. "He was well-liked. He did whatever was asked of him and then some."

A childhood friend, Carroll Hanson of Thonotosassa, said Angus grew as a person in the Marines.

"The Marine Corps made him a man," said Hanson, 28. "It made him blossom. It brought out all the best in him. It made him shine."

Angus served in Iraq from July 2004 to February 2005 and again from December 2005 to March 2006.

He was promoted to the rank of sergeant on May 1, 2007. Along the way, he was awarded the Combat Action Ribbon, two Good Conduct Medals, Afghanistan Campaign Medal, Iraq Campaign Medal, the Global War on Terrorism Service Medal and a number of service decorations.

"He was an excellent Marine," Kathy Angus said from Dover, Del., where she awaited the return of her son's remains. "The structure was good for him. He was an excellent leader."

Also killed in the operation were Lance Cpl. Timothy J. Poole, 22, of Bowling Green, Ky., and Lance Cpl. Zachary D. Smith, 19, of Hornell, N.Y.

Angus and Smith, both riflemen, were assigned to 1st Battalion, 6th Marine Regiment, Regimental Combat Team 7, and 2nd Marine Expeditionary Brigade based in Camp Lejeune, N.C.

Poole was assigned to 1st Battalion, 3rd Marine Regiment, 3rd Marine Division, III Marine Expeditionary Force, Kaneohe Bay, Hawaii.

The Marines were a part of the first wave of the 30,000 military personnel surge sent to Afghanistan in hopes of defeating al-Qaida and the Taliban. Soldiers from the 1st Battalion were expecting to face a bloody fight, according to a Chinese television station report in December.

Angus was interviewed for the December story.

"It's a jump-and-run kind of thing," Angus told the television reporter. "You never know when you are going to go. It is not my first Christmas away from home. It is not going to be my last."

The veteran Marine had no way of knowing that it would be.

Now he leaves behind a wife, Bonnie, whom he married just days before he left for Afghanistan on Dec. 17. The couple has a daughter, Kaitlyn, who will turn 2 in March. Bonnie Angus and their daughter live in Kingston, Tenn., Kathy Angus said.

"They thought they were going to get old and fat together," Kathy Angus said. "Obviously, that's not going to happen."

Born in New York State, Daniel Angus and his family moved to the Thonotosassa area when he was 2. After graduating from Armwood, he began working a construction job in the area, but there was little opportunity for him, his mother said.

"He wanted more for his life," Kathy Angus said.

Outside of military life, Angus loved the outdoors, especially going to the mud hole. He had a big four wheeler that he drove in the woods and through the mud. He also owned a huge pickup that he used to cruise the town and to also go mudding, Kathy Angus said.

He liked to fish and hunt, too.

"He was my only son," Kathy Angus said. "I have a daughter, but he was my only son."

Along with his wife, daughter and mother, he is survived by his father, William "Skip" Angus, and a sister, Tracy Maizille, both of Thonotosassa.

Tentative funeral arrangements are planned for Feb. 6 at Serenity Meadows Memorial Park in Riverview. A military funeral will be held at the Florida National Cemetery in Bushnell, Kathy Angus said.
